



## **Future Leaders Program Terms & Conditions**

### **Future Leaders Grand Prize Includes**

- One (1) roundtrip, economy class airfare from the major airport nearest the winner's home to San Diego International Airport up to \$1,000 or roundtrip travel by personal auto to/from home and Omni Last Costa Resort & Spa up to \$800.

- b. Incidental expenses, room upgrades, and any additional services are at the winner's expense.
